

Ann Kleine: Four Decades of Service to Midland Memorial Hospital

Midland Memorial Foundation was saddened by the passing of our friend, Ann Kleine on January 10. Ann was a proud Texas native with a passion for volunteering. She volunteered for the Midland Memorial Hospital Auxiliary for over 40 years and served two terms as president, as well as chair of the Quality Improvement, Ways and Means and Projects Committees. The Board of Trustees at Midland Memorial Hospital also benefited from her leadership. After serving 12 years as a Trustee, she was nominated to the Board of Governors where she served from 2007-2019. In 2020 she became a Governor Emeritus.

For more than 55 years, Ann was an active member of St. Ann's Catholic Church where she also volunteered on the Altar Society and served as president twice. In 2013, Ann was recognized with the esteemed Golden Deeds Award, presented to her by the Midland Exchange Club. This honor is reserved for, "the quiet good deeds of America's unsung heroes."

In 2008 she established the Ann M. Kleine Nursing Scholarship Endowment Fund to provide funding for tuition, fees, and books for nurses pursuing an advanced healthcare degree. Ann was a generous and devoted community leader offering a helping hand to



Melba was a member of Children's Service League, Senior Services, Trinity School Board, Midland College and Samaritan Family Counseling Center. She was an original member of the Permian Basin Area Foundation, as well as a member of their Board of Governors. Melba and Moose were excellent examples to their children of the value of serving their community. Following in their parents' footsteps, their daughters, Georgia and Sidney continue to

serve the Midland community to this day. Georgia was an active member of Midland Memorial Hospital Board of Trustees for 25 years and, in 2017, began serving on Midland Memorial Foundation's Board of Governors. She also served on the boards of High Sky Children's Ranch, United Way, Permian Basin Area Foundation, Permian Basin Petroleum Museum and Midland Country Club. Sidney has also been active in the community though the Junior League of Midland, Holy Trinity Episcopal Church and Trinity School, where she currently serves on the Trinity School Board of Trustees.
