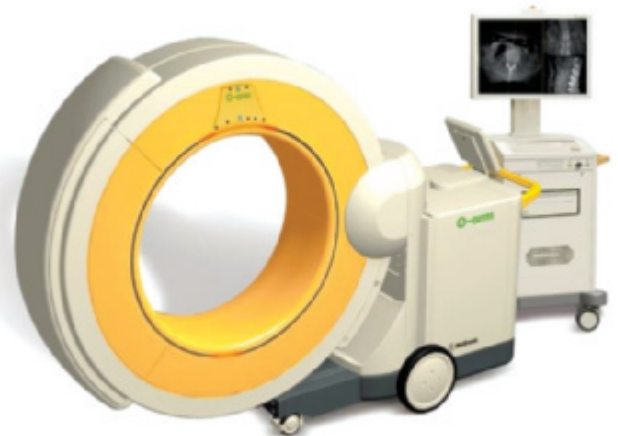
Discover Where Your Giving Goes Medtronic O-Arm Surgical Imaging and Navigation System

As fiscal year 2016 came to a close, the Board of Governors and Midland Memorial Foundation provided \$885,565 in funding to purchase the Medtronic O-Arm Surgical Imaging and Navigation System.

The O-Arm Surgical Imaging and Navigation System provides high-quality 3-D/CT images during surgical spine procedures. The advanced imaging capabilities, along with interactive navigation tools, offers the surgeon real-time guidance while performing intricate surgical procedures. There are many benefits from utilizing a system that can perform 3-D/CT images with interactive navigation during a surgical case. These include:

- Accuracy during implant placement and confirmation of implant placement, thereby reducing revision surgeries and the length of hospital stays.
- Reduction of radiation exposure and elimination of post-op x-rays or CTs examinations.
- Shorter surgical time and improved efficiency within the operating room and improved patient outcomes.

The O-Arm system has brought intraoperative imaging to a new level, with superior image quality and large field-of-view 3-D image sets, providing surgeons with the information they need precisely when they need it. This allows the surgeon to plan, implement, and confirm success of the surgical procedure before the patient leaves the operating room.

Dodge the Tax Bite at the End of the Year

The end of the year is a time to reflect upon the past. It's also an excellent time to look to the future and to support your favorite charities.

Follow these three steps to take advantage of tax-saving strategies as you set your charitable and financial goals.

1 **First Things First**

To begin, make a list of the causes you would like to support. For an idea of tax liability, calculate your income. If, for example, you sold appreciated assets this calendar year, or if for any other reason you may have a larger-than-normal tax bill, move forward some of your anticipated giving for next year to create a larger deduction this year.

2 **Get a Charitable Income Tax Deduction**

Cash, real estate, personal property and stocks are among the most popular charitable gifts. Depending on the gift, you are generally eligible for a charitable income tax deduction that can be as high as 30 to 50 percent of your adjusted gross income.

3 **Watch the Calendar**

All gifts must be completed by Dec. 31 to qualify for an income tax deduction this year. Cash contributions sent by mail are deductible if they are mailed by midnight on Dec. 31. Gifts of securities are deductible on the date they are transferred to the charitable organization's books—not the date you ask your broker to make the transfer. In most states, real estate gifts are considered completed on the date a properly executed deed is delivered to the organization.

To play it safe, give early. To be doubly safe, contact a tax advisor to discuss your giving options and strategies. And feel free to call Midland Memorial Foundation at any time.
